SCOUT LAW EMPHASIS: REVERENT

A Scout is Reverent. How does "Winter Wonderland" relate to this point of the Scout Law?

As winter comes, it brings with it a wonderland of snow, peace, beauty, and holidays. All of us come from different backgrounds and celebrate many traditions; each of our traditions give us an identity and a sense of belonging. When we share those traditions and accept others' traditions, we expand our circle so everyone feels like they belong. But no matter who we are or what we celebrate, we are all part of a great organization that has taught us to show reverence for others and their beliefs.

Scouts can build skills that will help exhibit this Scout Law through working towards the American Culture Merit Badge. Another suggestion is the Religious Emblem Program. Encourage Scouts to work on advancement requirements that focus on these topics. Additionally, use the winter months to hone those outdoor activities with the Snow Sports and Wildnerness Survival Merit Badges.

Speakers should plan for no more than 10-12 minutes and include time for questions and interactions with the Scouts. If no speakers are available, play a game themed around the topic, such as <a href="Name That Tune">Name That Tune</a>, <a href="Zoom Bingo">Zoom Bingo</a>, <a href="Charades">Charades</a>, or <a href="Pictionary">Pictionary</a>. Teach them how to create their own fun at home by creating a game such as <a href="Snowman Slam">Snowman Slam</a>.

#### Notes to the Unit Leader

This month, most of our counties remain in Phase 2 of Washington's Safe Start plan. While meetings should be held virtually, our Scouts still need the same sense of connection and community that a weekly meeting provides. Prior planning can maximize the best use of time, and meetings should last no more than 60 minutes. The current rule for in-person activities is no more than 5 individuals outside your own household, for outdoor activities only.

For units from Island County, which has proceeded to Phase 3, in-person meetings with groups of up to 10 individuals (minimum of 2 registered adult leaders) can be held. Cub Scout meetings should plan for groups of 5 youth and 5 adults.

So much of our Scouts' lives right now revolve around their screens, and Scouting can easily become "one more zoom meeting" on their calendar. When planning your meetings do your best to avoid long speeches or presentations, and account for time for the Scouts to socialize and catch up with each other.

Consider inviting Scouts to use a common virtual background (where possible) and they should always wear their Scout Uniform. Lots of different voices are great for breaking up the meeting, so consider inviting guest speakers to attend to share expertise or experiences with the Scouts.
